Greystones Bowling Club Data Privacy Notice

1. Personal data

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation (GDPR).

2. Data Controller - Data Subject

Greystones Bowling Club is the *data controller* (contact details below). This means it decides how your personal data is processed and for what purposes.

The *data subject* is the individual whose information is held by Greystones Bowling Club.

3. Data collected

Greystones Bowling Club will need to collect the following:

- Name
- Address
- Email address
- Telephone number

and, in situations where proof of age is required for competitions

• Date of birth

Greystones Bowling Club may also hold the following:

- Photographs of you.
- Records of when you contacted us or we contacted you either by telephone, email or by any other means.
- Any disciplinary information or details of any issues you have with us, or we have with you.

4. Processing of personal data

Greystones Bowling Club complies with its obligations under the GDPR by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

Data is processed only on the explicit consent of the data subject (you).

5. Use of personal data

Greystones Bowling Club will use your personal data for one or more of the following purposes:

- to facilitate communication with Greystones Bowling Club members regarding the affairs of Greystones Bowling Club
- to facilitate communication with Officers, Honorary Members and Selectors of Greystones Bowling Club
- to record the delegates entitled to attend the Annual General Meeting of Greystones Bowling Club
- to publish relevant data on the Greystones Bowling Club website
- to facilitate communication between Greystones Bowling Club and other clubs
- to allow bowling associations to organise competitions

6. Sharing of personal data

Greystones Bowling Club will only share your data with third parties with your consent.

7. Data retention

Data will be deleted from the records of Greystones Bowling Club as soon as it becomes obsolete.

8. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data:

- The right to request a copy of your personal data which Greystones Bowling Club holds about you;
- The right to request that Greystones Bowling Club corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased when it is no longer necessary for Greystones Bowling Club to retain such data;
- The right to withdraw your consent to the processing of your personal data at any time;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to lodge a complaint with the Information Commissioners Office.

9. Further processing

If Greystones Bowling Club wishes to use your personal data for a new purpose, not covered by this Data Privacy Notice, then Greystones Bowling Club will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, Greystones Bowling Club will seek your prior consent to the new processing.
